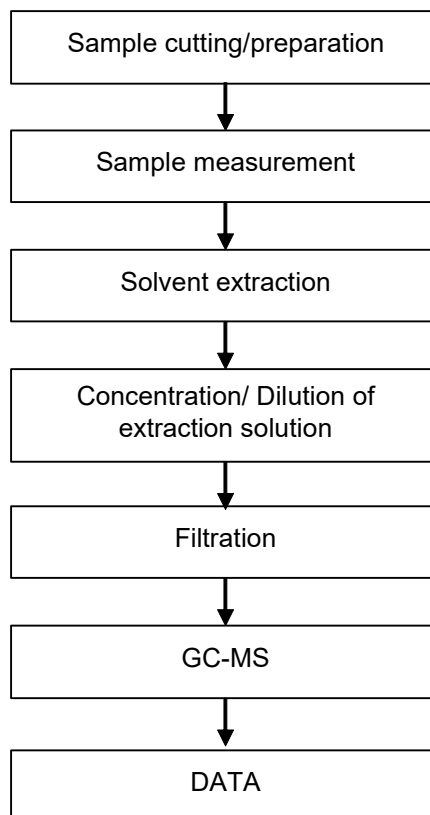

### PBBs/PBDEs Testing Flow Chart

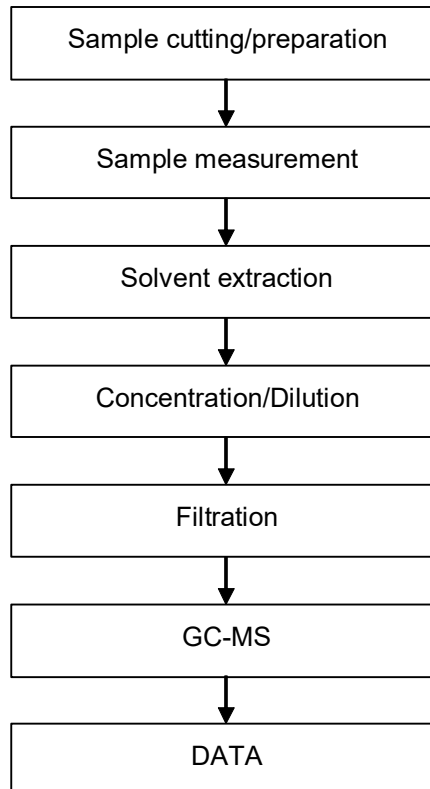

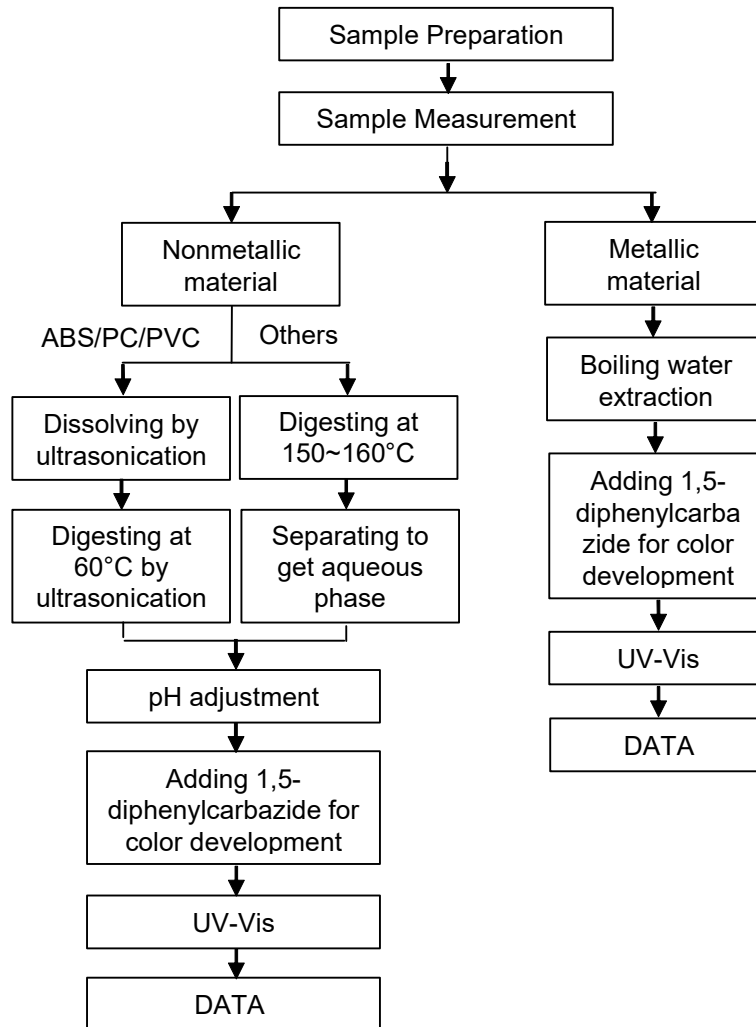

### Hexavalent Chromium (Cr(VI)) Testing Flow Chart



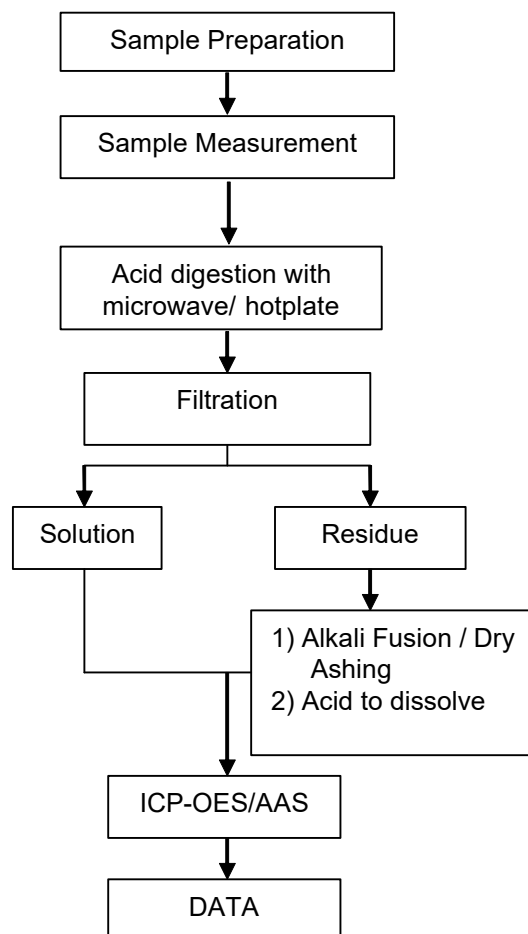

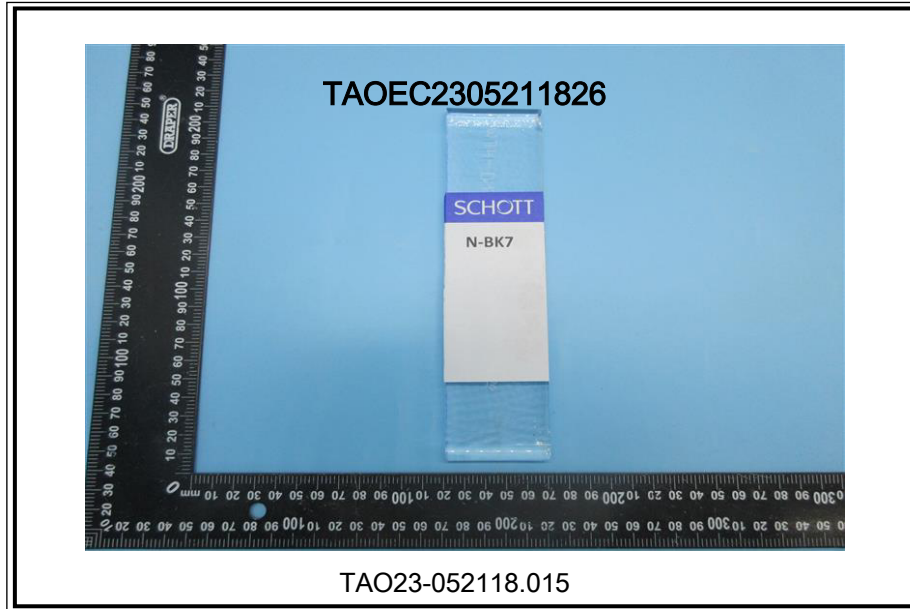
